



INTRODUCTION

In 2022, Congresswoman Strickland continued advocating on behalf of residents living in Washington's 10th Congressional District. Congresswoman Strickland recovered over \$3.5 million from government agencies for constituents – everything from expediting tax returns to PPP loan forgiveness. Since taking office in January 2021, she's helped over 1,000 people and organizations across the South Sound. She knows that the government works for the people. She delivered over \$815 million of investment into Washington state and starting this year, will lower out-of-pocket costs for over 143,000 Medicare beneficiaries in the South Sound through the Inflation Reduction Act.



PUTTING CONSTITUENTS FIRST

In her second year in office, Congresswoman Strickland continued fighting for the South Sound.

In 2022, Congresswoman Strickland helped over 468 constituents and returned over \$3.5 million back to residents of Pierce, Thurston, and Mason counties. She nominated 30 talented applicants to the U.S. Military Service Academies and delivered over 70 American flags, including flags that were flown over the U.S. Capitol building, to constituents. In addition, Congresswoman Strickland announced over \$815 million in federal grant funding for organizations across Washington's 10th district.

ACTIVELY WORKING TO REDUCE INFLATION

Coming out of the pandemic in late 2021 and into 2022, families, seniors, and veterans across the South Sound felt the impacts of inflation. A global economic phenomenon, this past year's inflation demonstrated how increases in demand for certain goods are straining the world's ability to supply those goods, especially coming out of a pandemic.

Early on, Congresswoman Strickland noticed the increasing costs of goods and services and helped form the New Democrat Coalition Inflation Working Group. This group formulated policies to help reduce impacts of inflation on the American people. Taking those ideas and other measures backed by global economic experts – especially on the medical cost front – Congresswoman Strickland proudly voted for the Inflation Reduction Act. After being signed into law late summer 2022, this Act is set to:

- Cap insulin at \$35.
- Lower prescription drug costs and caps Medicare beneficiaries' yearly out-of-pocket expenses at \$2,000.
- Save Americans an average of about \$800 per year on their health care premiums.
- Empower the Department of Health and Human Services to negotiate prescription drug prices for high-priced drugs in Medicare.
- Require drug manufacturers to pay a rebate to Medicare if they increase their prices faster than the rate of inflation.
- Lower energy costs by hundreds of dollars per year for families.

- Provide \$3 billion for the Neighborhood Access and Equity Grant Program – an effort Congresswoman Strickland helped lead to better support disadvantaged communities.
- Improve access to vaccines and biosimilars and increase support for low-income beneficiaries.
- Offer a tax credit of up to \$7,500 for qualified electric vehicles.
- Create 9 million jobs by investing in clean energy, energy efficiency, and clean manufacturing.
- Boost the tax credit for installing energy-efficient products.







INVESTING IN SCIENCE, TECHNOLOGY, AND JOB CREATION

To compete on the world stage and foster economic security, Congresswoman Strickland recognized that we must invest in American workers, manufacturing and businesses. That is why she fought to pass the bipartisan CHIPS and Science Act, which will alleviate the supply chain crisis, strengthen American innovation, and ensure the South Sound is placed on a path for a full and equitable recovery. This is on top of the more than 25,000 South Sound jobs Congresswoman Strickland has helped create since 2021.

As a small business owner, I submitted an application to the Small Business Administration (SBA) for the Economic Injury Disaster Loan (EIDL). My application was originally denied, so I asked for reconsideration but did not get a response from the SBA. SUPPORTING OUR SERVICEMEMBERS AND THEIR FAMILIES

As the daughter of a veteran, Congresswoman Strickland will always fight to improve the lives of servicemembers and their families, especially at Joint Base Lewis-McChord. This includes creating easier access to safe and affordable housing. In this year's defense policy bill, Congresswoman Strickland enacted numerous policies to make housing more affordable for servicemembers and their families. These include:

- The BAH Calculation Improvement Act which create a more transparent and modernized option to calculate the Basic Allowance for Housing (BAH) rates.
- The BAH Restoration Act which directs the Department of Defense to consider reversing the housing allowance reduction and restoring servicemembers to 100 percent of the calculated Basic Allowance for Housing.
- The Increasing Homeownership for Servicemembers which requires the Department of Defense to conduct a study of the barriers

to homeownership for members of the Armed Forces so that the opportunity to own a home and build family wealth is within reach for servicemembers.

 In addition to lowering cost and homeownership barriers for service members and their families, Congresswoman Strickland also tackled increasing access to childcare and ensuring that the military is prepared for the future in this year's bill.

FIGHTING FOR OUR VETERANS

The South Sound is home to a large veteran population and Congresswoman Strickland has made it a priority to always fight to improve their lives. This year, Congresswoman Strickland helped pass the Honoring Our PACT Act, which ensures that up to 3.5 million veterans who were exposed to toxic chemicals can access the health care services they need.
